### WHY STUDY FINANCIAL LITERACY EDUCATION?

The skill set in Financial Literacy Education is a great way to enhance any community services role or to move into working in financial literacy education roles. This course provides a set of skills for provision of basic financial literacy education to be used with clients and is not financial counselling.

This skill set is not a full qualification, is easier to achieve and sets the participant on a study and work pathway. Find ways of supporting people to change their money story and learn a bit about practical advice, support, and financial literacy education by undertaking this course. Financial literacy education

workers provide direct client support and group education about financial literacy and assist financial wellbeing.

If you're working in a community services or related role and want to enhance your work with clients, then this is the course for you!

### WHAT ARE THE OUTCOMES?

Successful completion of the Financial Literacy Education course assists the participant to gain the skills and knowledge required to apply these skills in financial capability and financial literacy education roles. Financial Literacy Education is recognised nationally and is a required skill set for people employed as financial literacy education workers and is desirable

for many community services workers to enhance their skills and provide a more holistic approach to working with their clients.

### STUDENTS WILL LEARN HOW TO:

- ▶ Understand your own money story and how that influences the way you work with clients
- ▶ Tell others about important financial facts and rights
- ▶ Understand the financial challenges of individuals
- ▶ Apply client centred practices
- ▶ Identify financial needs of people from specific demographics
- ▶ Refer clients to other services including financial counselling

## About the course

The skill set in Financial Literacy Education comprises 3 units of study and is nationally accredited. The skill set is not a full qualification and comprises the following 3 units of study:

### CHCEDU005

Work with clients to identify financial literacy education needs

### CHCEDU006

Improve clients' fundamental financial literacy skills

### CHCEDU007

Provide group education on consumer credit and debt

## Entry requirements

There are no course prerequisite qualifications, however students are required to demonstrate literacy and numeracy skills in line with Certificate IV level studies and be able to commit at four to six hours of personal study time in addition to class time. Applicants should have interest and/or relevant experience in the social and community services field and have the appropriate maturity and interpersonal skills to work with a diverse range of people.

Students must also have good computer skills.

## Delivery mode and duration

This course is delivered live online (in 'real-time') across 3 full days; with 4 additional weeks to complete assessments.

## Course fees
